**Topic:** Fireworks Contract

Issue & Analysis: The ACLPOA Fireworks program is planned for Saturday, July 2. 2022. Bids were sent to the following six vendors: J&M Displays, Mad Bomber Fireworks Productions, Melrose Pyrotechnics, S&N Fireworks Displays, Kastner Pyrotechnics, and Chrome Fireworks.

Responses were received from two vendors, J&M Displays and Mad Bomber. S&N Fireworks Displays, Melrose Pyrotechnics, Chrome Fireworks, and Kastner Pyrotechnics LLC chose not to submit quotes. Dan from Mad Bomber indicated that their quote is higher due to increasing costs, but he did quote the same show that we had in 2019 for the 50th anniversary. J&M Displays quote is \$8,000 but is a smaller show than past years and almost 400 shells less than the Mad Bombers quote.

Our recommendation would be to stick with Mad Bomber as they know the location, and what it entails. Mad Bomber has been our fireworks display provider for the past six years. They did not charge us in 2020 when the show was canceled due to covid, and they have always been accommodating with our requests.

Recommendation: To approve the three-year contract with Mad Bomber Fireworks Productions.

**Topic:** Adding fish structure to the lake

In 2021, an ACL owner donated PVC pallets to the Association for the use of building new fish habitat for the lake. At their November meeting, the Conservation Commission discussed with lake consultant, Joe Rush, use of these pallets to create new fish habitat for the lake. Triangles and cubes would be constructed and then tree branches would be stuffed into the structure and then sunk throughout the lake. The Association will continue to also use trees as fish habitat, but the PVC structures will give us more opportunity for fish structure and these structures will last longer than the trees that are dropped into the lake. The Conservation Commission does not know at this time where the structures will be located or how many would be dropped. They will be using the expert knowledge of Joe Rush to determine the best locations for the new habitat and the amount of habitat that will be dropped. Any new fish structures will be added to the Fish Habitat Structures Map.



Topic: Safety and Security UTV

Issue & Analysis: During the 2022 budget meetings, the Safety and Security Department made a request to replace the UTV. They submitted two bids, one for a machine that had hard doors, but was not enclosed, and one bid for a machine that was enclosed. They preferred the enclosed UTV due to their radio, sirens and wiring for equipment being exposed to dust, rain, and mud with an open machine. The enclosed machine will also allow for the UTV to be temperature controlled. In the summer, shifts on the trails are typically 8-10 hours, so an enclosed machine would mean staff on the trails more in the summer months, and it would also allow Security to utilize the UTV in the winter months. Ultimately, their request for an enclosed machine was denied, and Security was awarded \$19,500 for an open machine with hard doors. Since the budget was approved, further discussions have been ongoing about upgrading the UTV since the UTV is essentially utilized by the department as a squad. Julie Janssen has obtained new quotes for an enclosed UTV, but availability of machines has been difficult, and each location is allocated a certain number of machines each month. For Polaris, only the Northstar version has the air and heat package. For Can Am, the Defender package includes air and heat.

Full Throttle cannot submit a quote because they do not have any more allocation for 2022. Monroe Power Sports submitted a quote for Polaris Northstar and a Can Am Defender, but they have also told us that there will be a 5% increase in the cost of the machine if it is delivered after April 1st. Eastland Motor Sports quoted a Can Am Defender. Midwest Motorsports of Kieler, WI also did not provide a quote. Since we are not certain what availability each of these sellers will have and we know prices are going up soon, we are requesting the budget for the Safety and Security UTV be increased to a price not to exceed \$33,000, but to not name a specific retailer. Once we are able to locate a machine, time will be of the essence, and we need to be able to purchase it as soon as possible.

**Recommendation:** To approve the purchase of new UTV for Safety and Security for a price not to exceed \$33,000 with the additional money also coming out of the 2022 R&R Budget.

**Topic:** Weed Harvester Motor

Issue & Analysis: In 2018, the weed harvester started to have issues with a knocking sound in the motor. The Maintenance mechanic at the time was able to address the problem but stated that it was only a temporary fix, and the motor would eventually need to be replaced. Since 2018, the ACL mechanic checked oil and other fluids weekly, but in September of 2021, the motor no longer worked. A rod bearing went out damaging the head and injectors and ruined the crank shaft and cylinder walls. The Maintenance Department has obtained three bids, one from Inland Lake Harvester, the company that built the harvester, but the quote does not include the price to transport the harvester to Burlington, WI and back. The quote for the Yanmar motor with ACL installing the motor does not include the cost of fabrication and hardware to retrofit the motor to our harvester plus a hoist to lift the new motor. The estimate for these expenses is between \$2,000 - \$4,000. The staff is also concerned with metal filings in the engine. The quote from Martin includes installation on ACL property done by Martin. The quote also includes a twelve-month warranty. Considering all the circumstances, we are recommending the Martin quote. With approval in February, we expect to have the motor delivered and installed by May, just in time for staff to start harvesting weeds on the lake.

<u>Recommendation:</u> To approve the purchase of new engine for the weed harvester to be purchased and installed from Martin Equipment of Rockford, IL for an amount not to exceed \$24,000 to be paid out of the 2022 R&R Budget.

Topic: Additional funding for dock poles

Issue & Analysis: After the flood of 2017, the Board approved the purchase of 20' steel poles that would be used on the dock so that each dock would have poles that were out of the water at least six feet. When the ACL Maintenance Department attempted to start this project, they realized that our equipment was not sufficient to complete the project. In 2021, the R&R Budget included \$40,000 for the installation of new dock poles to be completed by the company that also installed rip rap. Frentress was awarded this project and submitted a bid of \$40,000 for the installation of the dock poles. Frentress stated that the bid was based on an estimate of time and materials, but they were not confident in the quote until they started the work and found out how the installation of the new poles would work. During the project, it was decided to add a bracket for the poles for more stabilization of the docks, it was also communicated that the project was taking more time than expected. Both ACL and Frentress wanted to complete the project before the first ice of the year, so the project proceeded. The final price for the project is \$54,892. The additional funds will come out of the 2021 R&R Budget.

**Recommendation:** To approve the additional funds for the installation of dock poles in the amount of \$14,892 payable to Frentress Lake Marina Dredging in East Dubuque, IA with the money coming out of the 2021 R&R Budget.

Topic: Location of New Boat Docks

The Maintenance Department is constructing these docks now, so they will be ready to be placed on the lake once ice is off the lake. The placement of the docks will be in the Broken Bow (Winchester) Bay. We would prefer to place two of the docks between the existing docks on the northwest side of the bay. The third dock will be placed on the northwest side, but closer to the trail. A pathway will need to be constructed for access to these docks. Work will also be done to create more parking for the two other docks.

**Recommendation:** To approve the placement of 32 new boat slips to be placed in the Broken Bow (Winchester) Bay area as per the attached plans.







<u>Analysis:</u> The Rules & Regulations Commission recommends to the ACL Board of Directors to approve the amendment to Section VI. Boating, D. General, to read "All boats shall be operated at a no wake speed after sunset and before sunrise."

The current rule reads "4. All boats shall be operated at a no wake speed after sunset and before sunrise as established by the U.S. Weather Bureau, Dubuque, Iowa." The reference to the U.S. Weather Bureau, Dubuque, Iowa is no longer relevant – this Weather Bureau no longer exists and cannot be referenced. With modern technology, anyone can look up the sunrise and sunset times on their smartphone.

**Topic:** Rules & Regulations: Go-carts – 1st Reading

Analysis: Association Office staff were presented with a vehicle purchased by a property owner identified as a go-cart by the manufacturer. By appearance, the vehicle did not fit our understanding of a go-cart, but because it had been identified as a go-cart by the manufacturer, it was not allowed to be registered. The owner was upset and asked what the difference between this vehicle and an RZR was. The current Rules & Regulations read "B. Prohibited Vehicles, 1. Amphibious vehicles, go-carts, and 2- and 3-wheel motorized vehicles are not permitted on the trail system." Go-cart is not defined anywhere else in the document. Staff requested that the Rules & Regulations Commission define what a go-cart is.

After many months of discussion between staff, the Rules & Regulations Commission, and the Trails Commission, we have collectively created a definition of a go-cart. That definition is "Go-Cart" – A small vehicle having a lightweight body and low ground clearance wherein the driver operates the vehicle with legs extended to reach the pedals." The Rules & Regulations Commission motioned at their December 3 meeting to approve this definition.



Mike Harris found some information that in WI if a snowmobile goes through the frozen lake, this information is listed under "Littering" with an amount of either a one-time fine or a per day fine. Mike Harris will attend the next Trails Commission meeting along with Vickie Sershon to discuss further and get the Commission's input on such criteria.
- **3.3 Paddle Boards, Kayaks, Canoes, Vinyl Vessels and other Non-Motorized Vessels** Chair Sershon reported State of IL recommendations are that a whistle and life jacket must be on these vessels. If 13 yrs. old and under, the life jacket must be worn and secured; if older, the life jacket must be situated on the vessel. If stopped for not having this safety equipment on board or being intoxicated, a fine will be issued. It is suggested for their safety, these vessels should stay close to the shoreline. Ms. Shamp also interjected these vessels must be registered with the ACL Office currently (with the exception of paddle boards). After a discussion, it was agreed Shaun and Julie will work on the proper verbiage and will bring back to Rules & Regs in September for their review.
- **3.4 Election of Officers** Mike Harris made the motion and George Drogosz seconded, that Chair Vickie Sershon continue as Chair of the Rules & Regs Commission. The Commission agreed unanimously. - "Person" means an individual, partnership, firm, corporation, and any body or association of individuals, or other entity.
- 5. "Proof of Insurance" shall be defined as an insurance company or insurance agency form that provides ACLPOA with the policyholder/named insured's name (must be a property owner of record), the amount of liability insurance coverage, a description of the insured vehicle(s), and the policy term expiration date.
- "Roadway" means that portion of a highway improved, designed or ordinarily used for vehicular traffic
- 7. "All-Terrain Vehicle" (ATV) Any motorized off-highway device, net weight of 900 pounds or less, traveling on four low pressure tires, designed with a seat designed to be straddled for operator use, and handlebars or steering wheel for steering control. ATVs are permitted on our trail system, subject to compliance with all other regulations contained herein.
- 8. "Utility Task Vehicle" (UTV)/"Side by Side Vehicle" Any motorized off-highway device, net weight 900 to 1,999 pounds, not a golf cart or low speed vehicle. Vehicle travels on four or more low pressure tires, with seating for at least two passengers in non-straddle type seats, designed with a steering wheel, brake lights, taillights, and two headlights. Four and six-wheel UTVs/Side by Sides are permitted on our trail system, subject to compliance with all other regulations contained herein.
- "Golf Cart" A small vehicle primarily designed or manufactured for transportation of persons for golfing. Golf carts are permitted on our trail system, subject to compliance with all other regulations contained herein.
- 10. "Go-Cart" A small vehicle having a lightweight or skeleton body and low ground clearance wherein the driver operates the vehicle with legs extended to reach the pedals.
- "Motorized Recreational Vehicle" Refers in these Rules & Regulations to vehicles allowed on the ACL trail system, including ATVs, UTVs/Side by Sides, and golf carts.
- "Other Authorized Trail Vehicles" Include snowmobiles (see Section XII Snowmobiles for regulations) and pedal bikes.
- 13. "Designated Trails" Trails designated by the Association Board of Directors for recreational use by pedestrians and/or motorized recreational vehicles. When using the trails, all pedestrians and motorized recreational vehicles must remain on the clearly marked designated trails located for such purposes within Apple Canyon Lake. Motorized vehicles are not permitted on any walking trail.

### **B. Prohibited Vehicles**

- 1. Amphibious vehicles, go-carts, and 2- and 3-wheel motorized vehicles are not permitted on the trail system. Any vehicle using a "skid steer" turning system is not permitted.
- With the exception of Emergency, Maintenance, and Security vehicles, licensed vehicles such as trucks, automobiles and motorcycles are not permitted on the trails.

### C. Registration

1. All motorized recreational vehicles that are to be on ACL trails must be registered annually and display a current ACL sticker on the center front of vehicle (front roll bar, windshield or front of hood panel so that sticker may be clearly seen from another approaching vehicle or trail walker) and ID numbers as issued by the ACL Association Office. The ID number will be displayed on both the front and rear of the vehicle. The ID numbers may be placed directly on the front center hood or on a front license plate and will also be
